

C. TAX AND INCOME INFORMATION

Dependent Students: You must provide copies of your and your parent(s)' 2006 Federal Tax Returns.

Independent Students: You must provide a copy of your (and your spouse's) 2006 Federal Tax Return.

Note: All tax filers must submit a **signed** copy of pages 1 and 2 of 2006 Federal Income Tax Return (includes 2006 IRS Form 1040, 1040A, 1040EZ, Telefile Tax Record, a tax return from Puerto Rico or a foreign income tax return).

If you did not keep a copy of your tax return, you can call the IRS at 1-800-829-1040. Press 2 "Refund or Personal Tax Account," then press 2 "Personal Account," follow the instructions until given the option to select a "tax return transcript" and then follow the instructions.
