



**ARTICULATION AGREEMENT  
BETWEEN  
ASHLAND UNIVERSITY AND MEDINA COUNTY CAREER CENTER  
*CTAG Criminal Justice to an Associate of Arts or Bachelor of Science in Criminal Justice***

It is agreed that Ashland University and Medina Career Center desire to have clear academic articulation agreement to enhance the transfer opportunities for students from Medina Career Center to Ashland University for the completion of an Associate's or Bachelor's Degree. This agreement is specific to Ohio Department of Education approved college transfer credit CTAG work only.

**Effective October 2023 through October 2025**

**PROVISIONS OF THE ACADEMIC  
PROGRAM ARTICULATION AGREEMENT:**

1. The student who successfully completes the CTAG Criminal Justice program will be provided official evidence by the Career-Technical Center for this credential.
2. The Medina Career Center affirms that the faculty overseeing and delivering the instruction of the Criminal Justice CTAG program are appropriately credentialed to meet or exceed ODE standards for this college transfer credit in Criminal Justice.
3. A student, who successfully completes the entire Criminal Justice CTAG program of study at Medina Career Center with a qualifying End-of-Course examination score and enrolls into an Ashland University Criminal Justice college degree program, either AA or BS, within three years will receive transfer credit for:

CJ 130 Introduction to Criminal Justice  
CJ 200 Criminal Investigation  
CJ 227 Corrections in the United States  
CJ 235 Courts and Justice  
HSEC 200 Policing in an Era of Homeland Security

the appropriate grade point average and appropriate semester hours of credit. This will be based on all grades earned from all schools attended. The Transfer Scholarship is only available to full-time students attending classes on the main campus.


12. Students transferring with less than 30 semester hours of transferable credit will transfer as freshmen. Students transferring with 30-59 semester hours of transferable credit will transfer as sophomores. Students transferring with 60-89 semester hours of transferable credit will transfer as juniors. Students transferring with 90 semester hours or more of transferable credit will transfer as seniors.
13. Medina Career Center and Ashland University agree to participate in regular review of program requirements and appropriate advising procedures, and make adjustments or amendments as deemed appropriate to maintain the integrity of each institution as well as for the improvement of the transfer process. Such changes will not adversely affect students already enrolled and covered under the provisions of the existing agreement.

This articulation agreement will be effective immediately after the representatives of both institutions sign the agreement. It may be modified upon mutual agreement; it may be terminated by either institution upon written notice to the other.
