

## 2024-2025 INDEPENDENT VERIFICATION WORKSHEET

Your FAFSA was selected for review by the U.S. Dept. of Education in a process called "Verification." Ashland University is required by federal regulations (34 CFR, Part 668) to verify that the data reported on your FAFSA is accurate before federal aid can be processed.

**INSTRUCTIONS:**

- **Documentation:** Complete this verification worksheet and submit along with the documentation requested in Section 3. The worksheet must be signed. Follow the instructions for tax information very carefully.
- **Deadline:** Documentation must be completed, signed, and submitted within **three weeks** of receipt of this notice.
- **Consequences for Failure to Submit Documentation:** Federal need-based grants, loans, and work study may be canceled entirely if Verification is not complete. You are responsible for any interest that accrues to your student account due to a delay in submitting documentation.
- **Notification of Offer Changes:** If there are differences between your FAFSA information and the information collected through Verification, the Financial Aid Office will electronically correct your FAFSA and notify you of any necessary adjustments to your financial aid offer letter. You will also receive a corrected FAFSA Submission Summary from the government.
