- > Deadline: Documentation must be completed, signed, and submitted within three weeks of receipt of this notice.
- Consequences for Failure to Submit Documentation: Federal need-based grants, loans, and work study may be canceled entirely if Verification is not complete. You are responsible for any interest that accrues on your student account due to a delay in submitting documentation.
- Notification of Offer Changes: If there are differences between your FAFSA information and the information collected through Verification, the Financial Aid Office will electronically correct your FAFSA and notify you of any necessary adjustments to your financial aid offer letter. You will also receive a corrected FAFSA Submission Summary from the government.
